- (i) An invitation to participate in the Scheme will be withdrawn if questions are not answered honestly or if the answers given are misleading or untrue. DOGS NSW reserves the right to seek verification of any information supplied by the applicant.
 - (ii) A candidate who fails any part of an examination three (3) times will be ineligible to apply for admission to the Judges Training Scheme for a period of two (2) years.
 - (iii) If a candidate passes a theory examination but fails to subsequently pass the practical examination, provided the candidate reapplies within three (3) years from the date of their original examination, the candidate will be exempt from resitting the theory examination.
 - (iv) Candidates will be required to complete a DOGS NSW Rules and Regulations Examination (unless this has previously been completed) and are also required to sit the relevant theory examination in the selected discipline.
 - (v) If accepted as a candidate, sign a release of DOGS NSW in respect of any liability arising out of the Examination, in such form as Dogs NSW may require.
 - (vi) Application for Acceptance into the Obedience, Endurance, Rally and Tracking Judges Training Scheme must meet the criteria set out In DOGS NSW Regulation Part VI Judges Performance Disciplines
