- Proof of importation (i.e. Health Permit/Export Permit or Import Permit), Animals from New Zealand are not required to have this document.  
*PLEASE NOTE if you have a DoA Release Form the Import Permit will not be required.*
- A copy of the Airway Bill is required as proof of shipment from the country of origin to Australia  
*PLEASE NOTE if you have a DoA Release Form the Airway Bill will not be required.*
