2.6(a) If, subsequent to Dogs NSW approval of a show to be conducted by an Agricultural Association, planned sections of the main show are formally cancelled by that Association, they may apply to the Board of Directors to conduct the Dog Section Show as scheduled, despite the absence of the requisite number of show sections actually being conducted at the show. Any such applications must detail the reasons for cancellation of the other Sections.

## 9.2 Regulations Part II Show - AMENDMENT - Clause 16.14

MOVED M Arthur SECONDED J Seary **THAT** Regulations Part II-Show, Clause 16.14, which currently reads as follows:-

- 16.14 (a) A member must not, at any time prior to or during a show, compromise or entertain a judge appointed in respect of that Show, in such a manner as could give rise to the influence that the member is attempting to influence the judge's attitude to the member or to an exhibit (whether owned by the member or another person). 7/99
  - (b) A breach of paragraph (a) is deemed to be misconduct. 7/99

### Be amended to read:-

- 16.14 (a) A member must not, at any time prior to or during a show, compromise or entertain a judge appointed in respect of that Show, in such a manner as could give rise to the <u>inference</u> that the member is attempting to influence the judge's attitude to the member or to an exhibit (whether owned by the member or another person).7/99
  - (b) A member is not to contact a judge after the announcement of that judge's appointment by any means that may be interpreted as promoting an exhibitor or an exhibitor's exhibits. This includes social networking sites, email and all electronic forms of communication as well as traditional forms of communication. Should a judge receive such an approach, they are required to make a report to Dogs NSW.
  - (c) A breach of paragraph (a) or (b) is deemed to be misconduct.

  - (i) at least five (5) calendar months prior to the date of such Show a Draft Show Schedule for the approval of the Dogs NSW Secretary in the form and containing such particulars as shall be required by the Council from time to time; and
  - (ii) within seven (7) days of its publication, at least one copy of the Show Schedule containing the information set out in the Draft Schedule as approved of by the Dogs NSW Secretary;

### Be clarified by adding an additional sub-clause numbered (iii) to read:-

(iii) An application to change any of the information approved in the original Draft Schedule application is required to be lodged with Dogs NSW within 24 hours of the Affiliate or Associate Affiliate Show Committee becoming aware of the need for such change.

#### **And Further**

**THAT** the words "the Council" in Sub-clause 5.1(c)(i) be changed to read "Dogs NSW" and, after the words "Dogs NSW Secretary." in Sub-clause 5.1(c)(ii), there be added the word "and".

**THAT** the full amended Regulation would then read:

- (c) There shall be prepared by the Show Secretary and lodged with the Dogs NSW Secretary:-
  - (i) at least five (5) calendar months prior to the date of such Show a Draft Show Schedule for the approval of the Dogs NSW Secretary in the form and containing such particulars as shall be required by Dogs NSW from time to time; and
  - (ii) within seven (7) days of its publication, at least one copy of the Show Schedule containing the information set out in the Draft Schedule as approved of by the Dogs NSW Secretary;
  - (iii) An application to change any of the information approved in the original Draft Schedule application is required to be lodged with Dogs NSW within 24 hours of the Affiliate or Associate Affiliate Show Committee becoming aware of the need for such change.

## 9.4 Regulations Part IV-Judges - AMENDMENT - Clause 4.2-N Keck

- 4.2 A Judge who has judged a Breed or Breeds or Classes of Breed or Breeds (other than Special Prize Classes) at a Show in NSW or, General Specials at an All Breeds Show in NSW, shall not (except in Classes of Special Prizes or otherwise with the prior written consent of the Board of Directors):-
  - (a) Judge the same Breed or Breeds or Classes of the same Breed or Breeds of dogs at another Show held in NSW within 200 kilometres by the shortest road of the first mentioned Show sooner than three (3) months thereafter. (The distance reference to be taken from www.travelmate.com.au). This Regulation does not apply in

- the case of a person who has been appointed as an Emergency Judge.
- (b) handle an exhibit that he/she has judged at another Show held within 6 months of the last date of the first mentioned Show; except in such case as the exhibit has been purchased or leased by the Judge after the said appointment and the transfer to the Judge as owner or part-owner has been duly registered in the Register prior to the commencement day of such Show.
- (c) In the case of General Specials, a Judge shall not judge
  General Specials at an All Breeds Show held within the
  Metropolitan Region, Newcastle & Lake Macquarie,
  Wollongong & Shellharbour local Government areas of NSW
  sooner than three (3) months thereafter.

## Be amended and expanded to two Clauses numbered 4.2 and 4.3 to read

- 4.2 A Judge who has judged a Breed or Breeds or Classes of Breed or Breeds (other than Special Prize Classes) at a Show recognised by any Member Body of ANKC shall not, (except in Classes of Special Prizes) or, otherwise with the prior written consent of the Board of Directors);
  - (a) Judge the same Breed or Breeds or Classes of the same Breed or Breeds of dogs at another Show held in NSW within 200 kilometres by the shortest road of the first mentioned Show sooner than 3 months thereafter. (The distance reference to be taken from <a href="https://www.travelmate.com.au">www.travelmate.com.au</a>).
  - (b) handle an exhibit that he/she has judged at another Show held within 6 months of the last date of the first mentioned Show; except in such case as the exhibit has been purchased or leased by the Judge after the said appointment and the transfer to the Judge as owner or part-owner has been duly registered in the Register prior to the commencement day of such Show.
- 4.3 A Judge may not judge General Specials at any All Breeds Show being held in the Metropolitan Region or in the Newcastle, Lake Macquarie or Wollongong & Shellharbour Local Government Areas of NSW, sooner than three (3) months after having done so at another show held within 200 kilometres, by the shortest road, of that subsequent show. (The distance reference to be taken from <a href="https://www.travelmate.com.au">www.travelmate.com.au</a>) or otherwise with the prior written consent of the Board of Directors.
