4.3 A Judge may not judge General Specials at any All Breeds Show being held in the Metropolitan Region or in the Newcastle, Lake Macquarie or Wollongong & Shellharbour Local Government Areas of NSW, sooner than three (3) months after having done so at another show held within 200 kilometres, by the shortest road, of that subsequent show. (The distance reference to be taken from <a href="https://www.google.com/maps">https://www.google.com/maps</a>) or otherwise with the prior written consent of the Board of Directors. (02/19)

Be re-numbered 4.3(a); AND an additional Clause, numbered 4.3(b), be included to read as follows:-

4.3(b) A Judge may not judge General Specials at any All Breeds Show being held outside the Metropolitan Region or in the Newcastle, Lake Macquarie or Wollongong & Shellharbour Local Government Areas of NSW, sooner than three (3) months within one (1) month after having done so at another show held within 200 250 kilometres, by the shortest road, of that subsequent show.
