- Photocopied or carbon entries are NOT acceptable
- Late or phone entries will NOT be accepted
- Payment by mail **MUST** be made by cheque or money order  
DO NOT send cash in the mail
- Bitches in oestrus may be shown **EXCEPT** in obedience, or if specified on show schedule
- If a Club needs to contract a "replacement" judge they are advised to take note of DOGS NSW Regulation Part II - Show, Section 12.6 (c), which relates to an exhibitor requesting a refund
- In accordance with DOGS NSW Regulations Part II - Show, Section 20.1, "Limitation of Exhibits for Judging", Clubs reserve the right to alter or amend judging arrangements and to substitute judges if deemed necessary under this Regulation.  
However this does not negate the Club's responsibilities in accordance with Part II - Show, Section 12.6 (c).
