Directors considered the request from Dogs Queensland Judge, Mrs U Greenwood for clarification of DOGS NSW Regulations Part IV-Judges, Clause 4.4(v), which reads:-

4.4(v) use a mobile phone, iPad, iPod or any other electronic device whilst he is carrying out his judging appointment in the ring. **(07/18)**

as Judges often use their electronic devices to confirm breed standards or when critiquing.

Directors agreed that consideration should be given to amending the Regulations to refer only to "electronic devices" in general and include "not to be used for communication purposes. Once DOGS NSW Regulations have been amended, Dogs Australia should be requested to also amend its Regulations accordingly.

6.5 **Spring Fair Dog Show Committee**

The Board noted that this Committee did not meet.

6.5.1 Neuter Class at CACIB Shows

Director C Rafton advised the meeting that advice has been sought from Dogs Australia regarding the conduct of Neuter Classes at the Spring Fair CACIB Show on the Friday requesting an expedient decision as the notices to all exhibitors, should the Class not be allowed to proceed, will require a notice almost immediately given the date of the show is around 3 weeks away.

The Spring Fair Committee relied upon the <u>Regulations published on the DOGS NSW</u> site as follows:-

DOGS NSW Regulations Part II-Show, Section 8B "ANKC/CACIB" Shows

ANKC Ltd, from time to time, authorise FCI/CACIB Shows and prescribe Regulations for their conduct which are found at Section 6 of ANKC Ltd Regulations Part 5 Show.

That Section, as amended from time to time, has been adopted in its entirety as a Regulation of DOGS NSW and will apply to the conduct of any FCI/CACIB show held in NSW.

- 8.1 (a) The following order for the judging of Breed, Group and General Special Classes shall be adopted wherever practicable: Best Exhibit; Runner-Up to Best Exhibit; Baby Puppy; Special or Minor Puppy; Puppy; Junior; Intermediate; Novice; Graduate; Limit; State Bred; Australian Bred; Open; Neuter, Runner Up to Best Neuter Exhibit, Best Puppy Neuter, Junior Neuter, Intermediate Neuter, Open Neuter. (12/16)
 - (b) The judging of General Special Classes at any Recognised Show shall not commence until 10 minutes after the completion of all General Classes. (11/02)

The Spring Fair Committee also relied upon the <u>Regulations published on the ANKC</u> site as follows:-

Section 8.1: Alternative In-Group and In-Show Placing System

Refers to Alternate in-Group and In-Show Placing System , which follows the FCI format and includes "Neuter"

NB: same methodology for judging as per FCI system

Dogs Australia Regulations Part 5: Conformation Shows, Section 9.1: Rules for the Conduct of FCI/CACIB Shows:

- 9.6.1 Breeds not recognised by FCI to be awarded a CACIB
 - American Hairless Terrier:
 - Anatolian Shepherd Dog;
 - Tenterfield Terrier
 - Bluetick Coonhound

NB: we did not adhere to the above as it is an incomplete list

- 9.7.1 there is only a list of classes:
 - Classes in which the CACIB cannot be awarded
 - Classes in which a CACIB can be awarded

<u>Nowhere</u> in the Regulations does Dogs Australia state the Classes listed that can be held as being <u>the only ones</u> allowed.

Observation:

It would appear that perhaps both DOGS NSW and Dogs Australia published Regulations are not up to date.

Please note:

- The judging of "Neuter' has always been separate to the judging of the other Classes of each.
- The CACIB will not be on offer to the Neuter class.

Hence: The option that may be able to accommodate the Exhibition of Neuters, which we are supposedly trying to promote amongst our members for exhibition could be:

- The competition for Neuter at the Friday show, which also awards Dogs Australia (ANKC) certificates and points, will be held in accordance with the Section 8 as a 'Separate Show' to align itself to the methodology of judging at the FCI CACIB show.
 - All Neuter exhibits in each Group will be judged at the end of all other breeds in that Group and after the Group Specials for the Classes exhibited in the CACIB section.
 - Accordingly, the In-Show awards will follow that same pattern.

The Executive Committee of Dogs Australia has now confirmed that a separate show for Neuters can be run in accordance with Dogs Australia Regulations.

6.5.2 2022 Spring Fair Update

Director C Rafton gave an update on the arrangements for the Spring Fair as follows:--

- once the current Lithuanian Judges has been granted a visa, however, her Husband has not. The Committee is currently sourcing a replacement and contact with be made with the proposed replacement Judge tonight to take over that section of the judging.
- There are four (4) different ovals required for Lure Coursing and although St Ives
 was available the conditions of the grounds was unsuitable as a result of the
 recent Circus held there. Therefore, the Lure Coursing has had to be cancelled.
- Herding has also been cancelled due to inability to secure suitable grounds.
- Agility and Obedience the Luddenham Showground can be used for the Saturday
 and Sunday and be shared with the GSD Fun Day. Booking has been made for the
 Saturday for Agility and the Sunday for Obedience, however, on the Sunday the
 dogs in the GSD Fun Day will be exhibited off leash and temperament tested with
 a starter pistol. A determination by the Obedience people is required as to
 whether they wish to proceed under these conditions.

Director K Hedberg BVSc agreed to speak with the GSD people to ascertain what time they will be doing the Gun Tests.

Director V Etherington requested advice be sought from the Operations Manager as to whether the GSDL grounds at Orchard Hills will be suitable for use for the Spring Fair Obedience in three (3) weeks' time.
