- Amendment to existing Section 9 relating to the rules for the conduct of FCI/CACIB Shows
- Addition of New Section 9A relating to the rules for the conduct of FCI Asia, Africa and Oceania Section (AAOS) A2O Shows
- Removal of Clause 2.4.2 which read:

"2.4.2 Catalogues are not to be made available prior to one hour before the advertised start time of a conformation show. Royal shows and cluster shows catalogues may be released one hour prior to the first day or first show."
