The large difference in rental payments for financial year 2022 to the previous year is due to the renewal of the lease by the Government, with only 16 years left for our occupation of these grounds. During this process it was discovered that previous 'reviews' of our rental amounts had not been done in regard to the annual fees charged as we had no increase for many years. This was, naturally, adjusted prior to the lease being renewed but the additional adjustment charged was negotiated for only a period of 20 from June 2020 to June 2022 and that amount resulted in an additional \$2,708.33 per month resulting in the \$67,971.25 included in the current 2022 figures.
