### CASUAL VENDORS AGREEMENT



#### **CONDITIONS OF LICENCE**

The Licensee described on the reverse side hereof will occupy any site granted to him pursuant to the conditions printed on the reverse and following: -

- 1. This license shall not commence before sunrise and shall not endure beyond sunset on the date to which it applies.
- 2. The Licensee shall be granted reasonable access to the site for the purposes of this licence.
- 3. The Licensor does not warrant that the site is fit for any particular purpose.
- 4. The Licensor shall not be liable for any loss or damage occasioned to or suffered by the Licensee, its servants or agents as a result of the granting of this license and/or the use of the site.
- 5. This license shall not confer upon the Licensee any estate right or interest in the site or any portion of the property to which the Lease referred to in the reverse side hereof relates and nothing here in contained shall be construed as creating the relationship of landlord and tenant as between the Licensor and the Licensee nor to abridge or qualify the absolute right of a Licensor, its servants, agents and workmen to be and remain upon the premises the subject of the said Lease and the Site.
- 6. Notwithstanding any other provision contained herein this licence may be revoked by the Licensor (including its duly authorised representative) at any time and without notice written or oral if the Licensee is in breach of the terms hereof.
- 7. The Licensee is hereby licensed to bring to the Site such chattels and temporary structures as shall be consistent with the licensed use and have been previously approved by the Licensor PROVIDED THAT:
  - a) All such items shall be removed by the expiration of the period covered by this license.
  - b) In bringing such items to the Site (and occupying same) the Licensee shall cause no inconvenience to the Licensor or Kennel Control or to any person upon or in the vicinity of the land the subject of the Lease or Site.
- 8. The Licensee shall make good any damage which might (notwithstanding the provisions hereof) be caused by bringing items to or taking them from the Site or by any other cause.
