All Judges visiting Australia to judge and are NOT receiving payment must apply for a 408 visa which is called a 'temporary activity' visa. All Judges coming to Australia to judge and receiving payment must apply for a working visa. There are several classes of this working visa (417/462), however it is important that those clubs paying Judges research which best suits their purposes.
